### 4. First Aid

#### General Information

#### Exposure

<b>Swallowed</b>	Do NOT induce vomiting. Give a glass of water to drink. Contact a doctor immediately. If vomiting occurs, place victim face downwards, with the head turned to the side and lower than the hips to prevent vomit entering the lungs.
<b>Eye contact</b>	IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTRE or doctor/physician.
<b>Skin contact</b>	IF ON SKIN: Wash with plenty of soap and water. If skin irritation or rash occurs: Get medical advice/attention. Wash contaminated clothing before reuse.
<b>Inhaled</b>	Generally, inhalation of vapour is unlikely to result in adverse health effects. If coughing, dizziness or shortness of breath is experienced, remove the patient to fresh air immediately. If patient is unconscious, place in the recovery position (on the side) for transport and contact a doctor.

### 5. Firefighting Measures

<b>Fire and explosion hazards:</b>	There are no specific risks for fire/explosion for this chemical. It is non-flammable.

### 6. Accidental Release Measures

<b>Containment</b>	If greater than 1000L is stored, secondary containment and emergency plans to manage any potential spills must be in place. In all cases design storage to prevent discharge to storm water.
<b>Emergency procedures</b>	In the event of spillage alert the fire brigade to location and give brief description of hazard. Stop the source of the leak, if safe to do so. Shut off all possible sources of ignition. Wear protective equipment to prevent skin, eye and respiratory exposure. Clear area of any unprotected personnel. Contain using sand, earth or vermiculite. Do not use sawdust. Prevent by whatever means possible any spillage from entering drains, sewers, or water courses. (If this occurs contact your regional council immediately).

**Clean-up method**

Use absorbent (soil, sand or other inert material). Rags are not recommended for the clean-up of spills, as they may create fire or environmental hazard. Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.

**Disposal**

Mop up and collect recoverable material into labelled containers for recycling or salvage. Recycle containers wherever possible. This material may be suitable for approved landfill. Dispose of only in accord with all regulations.

**Precautions**

Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation.

**7. Storage & Handling****Storage**

Avoid storage of harmful substances with food. Store out of reach of children. Containers should be kept closed in order to minimise contamination. Keep from extreme heat and open flames. Avoid contact with incompatible substances as listed in Section 10.

Keep exposure to a minimum, and minimise the quantities kept in work areas. See section 8 with regard to personal protective equipment requirements. Avoid skin and eye contact and inhalation of vapour, mist or aerosols.

**8. Exposure Controls / Personal Protective Equipment****Workplace Exposure Standards**

A workplace exposure standard (WES) has not been established by WorkSafe NZ for this product. There is a general limit of 3mg/m<sup>3</sup> for respirable particulates and 10mg/m<sup>3</sup> for inhalable particulates when limits have not otherwise been established.

**Engineering Controls**

In industrial situations, it is expected that employee exposure to hazardous substances will be controlled to a level as far below the WES as practicable by applying the hierarchy of control required by the Health and Safety at Work Act (2015) and the Health and Safety at Work (General Risk and Workplace Management) Regulations 2016. Exposure can be reduced by process modification, use of local exhaust ventilation, capturing substances at the source, or other methods. **Personal Protective Equipment****General**

Protect eyes with goggles, safety glasses or full face mask. Avoid wearing contact lenses.

Avoid repeated or prolonged skin contact. Wear overalls, rubber boots and impervious gloves. Replace frequently. Gloves should be checked for tears or holes before use. Remove protective clothing and wash exposed areas with soap and water prior to eating, drinking or smoking.

**Respiratory**

A respirator when airborne concentrations approach the WES (section 8). Use an organic vapour cartridge with a dust/particulate filter. If using a respirator, ensure that the cartridges are correct for the potential air contamination and are in good working order.
