6. Accidental Release Measures

Containment Emergency procedures

In all cases design storage to prevent discharge to storm water.
If a significant spill (>1000L) occurs:

Clean-up method

Use absorbent (soil, sand or other inert material). Rags are not recommended for the clean-up of spills, as they may create fire or environmental hazard. Engineering Controls
