## 5. Firefighting Measures

## 6. Accidental Release Measures

<b>Containment</b> <b>Emergency procedures</b>	In all cases design storage to prevent discharge to storm water. Generally, the containers size will limit a large spill from occurring. If a significant spill occurs: Stop leak if safe or necessary. Isolate area. Collect spill, see below. Transfer to container for disposal. Dispose of according to guidelines below (Section 13).
<b>Clean-up method</b>	This product is not considered flammable or ecotoxic. Small spills do not require any special clean up method. Larger spills (e.g., greater than 10kg) should be mopped up and collected.

### Engineering Controls
