### 5. Firefighting Measures

### 6. Accidental Release Measures

<b>Containment</b>	If greater than 10000L is stored, secondary containment and emergency plans to manage any potential spills must be in place. In all cases design storage to prevent discharge to storm water.
<b>Emergency procedures</b>	In the event of spillage alert the fire brigade to location and give brief description of hazard. Stop the source of the leak, if safe to do so. Wear protective equipment to prevent skin, eye and respiratory exposure. Clear area of any unprotected personnel. Contain using sand, earth or vermiculite. Do not use sawdust. #### Engineering Controls
